Incomplete bids not conforming strictly in the manner prescribed/offer shall not be considered and shall be summarily rejected.

Conditional Auction will be summarily rejected and EMD will be forfeited.

The offers submitted would be governed by all the terms and conditions as laid down in the prescribed Auction Form in addition to the terms & conditions indicated herein. There would be no post auction negotiation.

The Earnest money would be refundable to un-successful Bidder on finalisation of the Auction and shall carry no interest whatsoever.

The bidders will have to produce all or any documents in original whenever asked by the Institute. ICMR-NIIH reserves the right to seek any relevant documents (directly or indirectly) any time for clarification of any documents submitted.

The Director, ICMR-NIIH, Parel Mumbai - 12 reserves the right to accept or reject any or all auction bids without assigning any reason/notice whatsoever and are not bound to accept the highest auction rates. The Director, ICMR-NIIH, Parel Mumbai - 12 also reserves the right to scrap the auction enquiry at stage without assigning any reason and ICMR-NIIH will not be liable for any costs and consequences incurred by the intending bidder.

TERMS & CONDITIONS FOR THE SALE OF CONDEMNED UNSUABLE ITEMS THROUGH E-Auction

The bidders may submit duly filled Bid form along with all the requisite details through Gem portal up to **14.09.2022 11.00 AM** i.e. on last date of Auction.

The detail of Condemned Scientific Equipment's can be inspected physically by prospective Bidders at the respective places under **ICMR-NIIH, 13th Floor, KEM Hospital, Parel Mumbai - 400012**, during office hours, where those are lying on "AS IS WHERE IS BASIS".

The Institute does not guarantee to make any definite quantity and quality of articles available to the buyer.

The buyer is to quote rates separately for each item of articles. Rate for any number of items of articles can be quoted separately but in one auction form only.

The bid shall be submitted through GeM portal in reference to ICMR-National Institute of Immunohaematology and auction no. ICMR-NIIH/Condemned Unusable items/22-23 dated. 25.08.2022.

The auction form shall be filled in neatly and accurately.

The bid will be opened in the office of the Administrative Officer, Stores Dept, ICMR-NIIH Parel Mumbai - 12 through GeM portal at the scheduled date and time in the presence of the bidders or an authorized representative of the bidder.

The Institute reserves the right to accept or reject without assigning any reason, any bid partly or fully.

The successful bidders will be informed as to the acceptance of his/her bid by letter/mobile/e-mail and any other mode of communication.

The successful bidder after acceptance of her bid will be required to deposit cost within 07 (seven) working days from the date of issue of acceptance letter and will need to lift the stocks within a specified date from the issue of release order or such period as may be decided by the institute.

The articles can be inspected by the intending bidder on production of the letter at the depot from where the delivery will be given.

Any bribe, commission, gift or advantage offered or promised by or on behalf of the buyer or his partner, Agent, servant, or one of his or their behalf (whether with or without the knowledge of the buyer) to any officer or official of the institute shall (in addition to any criminal liability which the Auction may incur) debar his Auction from being considered.

Canvassing on the behalf of the bidder will also make his bid liable to rejection. The successful Bidders shall deposit the amount of the Auction within seven days of the acceptance of his Auction through DD/Cheque in favour of the Director, ICMR-NIIH Parel Mumbai - 12 failing which the Earnest money will be forfeited and the articles will be sold to next highest quoted rate Bidder.

All Taxes and other charges of any nature whatsoever liveable by any govt. authority shall be payable by the buyer in addition to the price offered.

The price calculated on the declared quantity in each on basis of accepted rates shall be paid together with taxes, if any within seven days of the acceptance of the bid by the competent Authority. The amount will be paid by the buyer through DD/ Cheque in favour of The Director, ICMR-NIIH Parel Mumbai covering the full value within seven days from the date of acceptance of the offer.

At the time of giving delivery if there is a shortage then the declared quantity, proportionate refund to the buyer will be allowed on presentation of duly supported bills, in the prescribed form. If any excess quantity is found, proportionate additional payment shall be made by the buyer in the same manner as referred to above, within seven days from the date of intimation to this effect by the Director, ICMR-National Institute Immunohaematology, 13th Floor KEM Hospital, Parel Mumbai – 400012.

The articles will be sold in the same condition as they exist on “As is where is basis”. The buyer shall lift the auctioned equipment within 7 (Seven) working days from the date of issue of release order.

The buyer shall make his own arrangements for transport and will not be entitled to claim any facility or assistance for transport from the institute. If the original buyer wishes to take delivery of the goods purchased through representative, he must authorize the representative by a letter of authority which shall be presented to the office in which the stock is held.

Lifting of the unusable items by proxy shall be at buyer’s sole responsibility and risk. No claim shall lie against the institute on any account whatsoever if delivery effected to a wrong person.

The unusable items sold to the buyer shall be from the date of acceptance of his auction and will be lie ICMR-NIIH Mumbai at his own risk. The institute shall not be responsible for the safe custody or preservation thereof.

If the unusable items are not lifted within the time specified in the release order, the institute may resell the items at the buyer’s risk/expense and cost. The buyer shall not be liable to claim the items from the institute at a later stage.

The storage charge will be @1% of the cost per day on sale price of said items thereof on uplifted items, these charges will be recovered before delivery of such items are actually affected or until the date of resale (Inclusive).

Delivery will be given during working hours on all working days on presentation of the release order by the buyer to the stock holder.
